## **RESOLUTION REPEALING RESOLUTION R-20-01 AND AMENDED RESOLUTION** R-13-02; RESOLUTION AUTHORIZING VILLAGE OF MARIEMONT TO ENTER INTO CONTRACT WITH HAMILTON COUNTY BOARD OF BUILDING APPEALS; AND TO DECLARE EMERGENCY

WHEREAS, the Village of Mariemont previously adopted and enforces the current version of the Residential Building Code of Ohio (hereinafter referred to as "The Code"), as and for its building codes within the limits of the Village of Mariemont; and

WHEREAS, the Rules and Law Committee has recommended that Village Council approve, adopt, and ratify the resolution of the Hamilton County Planning and Developments Board of Building Appeals relative to entering into a contract between the Village of Mariemont and the Hamilton County Planning and Development Board of Building Appeals for the purpose to hear and decide all issues pertaining to residential building code appeals; and

WHEREAS, Council for the Village of Mariemont believes it is in the best interest of the Village of Mariemont and has therefore agreed to adopt same.

## NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MARIEMONT, STATE OF OHIO, A MAJORITY OF THE MEMBERS DULY ELECTED THERETO CONCURRING:

SECTION I. Mariemont Resolution Nos. R-20-01 and R-13-02 are hereby repealed in their entirety.

SECTION II. The Village of Mariemont hereby approves, adopts, and ratifies this Resolution and authorizes the Village of Mariemont and its Building Commissioner to enter into a contract (Exhibit "A") with the Hamilton County Planning and Development Board of Building Appeals to hear all appeals relative to residential building code appeal matters.

SECTION III. That the Village of Mariemont shall continue to utilize the Ohio Department of Commerce, Board of Building Standards, to hear and decide all matters pertaining to appeals of Commercial Building Code matters within the Village of Mariemont.

SECTION IV. That this Resolution is hereby declared to be an emergency measure for the preservation of the public health, welfare and safety and should go into immediate effect due to the State of Ohio mandated due date
