# VILLAGE OF MARIEMONT, OHIO 

RESOLUTION NO. R-24-15

## TO AUTHORIZE OHIO DEPARTMENT OF TRANSPORTATION TO PROCEED WITH PROJECT PID NO. 99814 HAM-US50-30.23 RRFB; AND ENTER INTO CONTRACT; AND TO DECLARE EMERGENCY

WHEREAS, the following resolution enacted by the Village of Mariemont, Hamilton County, Ohio hereinafter referred to as the Local Public Agency (LPA), in the matter of the stated described project.

## SECTION I. - Project Description

## WHEREAS, the LPA has identified the need for the described project:

Installation of two Rectangular Rapid Flashing Beacons at the crosswalk near Wooster Pike (US-50) and Belmont Avenue. Construction of a raised median to provide pedestrian refuge. Replacement of sidewalk on the south side of Wooster Pike between Belmont and Harvard Acres.

# NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MARIEMONT, HAMLLTON COUNTY, OHIO, TWO THIRDS OF THE MEMBERS ELECTED THERETO CONCURRING: 

SECTION II. - Consent Statement
Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III. - Cooperation Statement
The LPA shall cooperate with the Director of Transportation in the above described project as follows:
1.) The Village is responsible for $100 \%$ of Preliminary Engineering and Right of Way phases of the project, plus the non-federal share of construction.
2.) Additionally, the Village is responsible for all cost for added construction items requested by the Village which are not necessary for the improvement as determined by the State and Federal Highway Administration.
3.) Additionally, the Village is responsible for all change orders and extra work contracts required to fulfill the construction contracts shall be processed as needed. The State shall not approve a change order or extra work contract until it first gives notice, in writing to the Village. The Village shall contribute its share of the cost of these items in accordance with other sections herein

## SECTION IV. - Utilities and Right-of-Way Statement

The LPA agrees that all right-of-way required for the described project will be acquired and/or made available in accordance with current State and Federal regulations. The LPA also understands that right-of-way costs include eligible utility costs.

The LPA agrees that all utility accommodation, relocation and reimbursement will comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

## SECTION V. - Maintenance

Upon completion of the Project, and uniless otherwise agreed, the Village shall: (1) provide adequate maintenance for the Project in accordance with all applicable state and federal laws, including, but not limited to, Title 23, U.S.C., Section 116; (2) provide ample financial provisions, as necessary, for the maintenance of the Project; (3) maintain the right-of-way, keeping it free of obstructions: and (4) hold said right-of-way inviolate for public highway purposes.

SECTION VI. - Authority to Sign
The Fiscal Officer and the Mayor for the Village of Mariemont are hereby empowered on behalf of the Village of Mariemont to enter into contracts with the Director of Transportation necessary to complete the above described project.

SECTION VII. That this Resolution is an emergency measure necessary for the health, safety and welfare of the Village. The reason for the emergency is to insure that the work gets completed during favorable weather.
