#### RESOLUTION AUTHORIZING CONSTRUCTION LOAN FOR MARIEMONT ADMINISTRATION BUILDING

WHEREAS, the Village of Mariemont is contemplating several improvements to the Mariemont Administration Building and as such have secured a grant in the amount of Four Hundred Thousand and no/100 Dollars (\$400,000.00) from the State of Ohio to aid in the costs of performing said improvements; and

WHEREAS, the Village is required to match said grant with funds it obtains on its own; and

WHEREAS, the Finance Committee has met and recommended that the Village of Mariemont obtain a traditional construction loan in the amount of Six Hundred Fifty Thousand and no/100 Dollars (\$650,000.00), over a repayment term of five years for assistance in the costs of performing improvements on the Mariemont Administration Building.

#### NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF MARIEMONT, STATE OF OHIO, TWO THIRDS OF THE MEMBERS DULY ELECTED THERETO CONCURRING:

**SECTION I.** That the Mayor be and is hereby authorized and directed to obtain a traditional construction loan in the amount of Six Hundred Fifty Thousand and no/100 Dollars (\$650,000.00) with a repayment term of five years for costs of improvements on the Mariemont Administration Building.

**SECTION II.** That the Fiscal Officer be and is hereby authorized to pay for said construction loan on such terms and to charge the same to 101.712.52409.

SECTION III. That this Resolution shall take effect at the earliest date allowed by law.
