## VILLAGE OF MARIEMONT REGULAR COUNCIL MEETING HELD IN COUNCIL CHAMBERS JANUARY 12, 2015

Mayor Policastro called the meeting to order at 7:00 p.m. with the Pledge of Allegiance to the flag. The following Council members answered present to roll call: Mr. Marsland, Mr. Miller, Ms. Palazzolo, Ms. Schwartz and Mr. Tinkham.

Ms. Palazzolo moved, seconded by Ms. Schwartz to excuse the absence of Mr. Wolter. On roll call; five ayes, no nays.

Mayor Policastro said Police Officer Nick Pittsley completed his 180 day probationary period and it is recommended by Chief Hines that he be made a Regular Full-Time employee. Officer Pittsley is a lifelong resident of Cincinnati having graduated from Archbishop McNicholas High School. He earned a Bachelor degree in political science from Northern Kentucky University. His family has a history in law enforcement with his grandfather being a New York police officer. He worked previously for the Hamilton County Sheriff's office for two years before being hired as a patrol officer with the Village of Mariemont on June 23, 2014. He has done an excellent job in his first six months. Mr. Tinkham moved, seconded by Mr. Marsland to make Officer Pittsley a Regular Full-Time employee. Officer Pittsley said he enjoys working for the Village and appreciated the opportunity to serve. On roll call; five ayes, no nays. Member of Council congratulated Officer Pittsley.

Mr. Marsland moved, seconded by Ms. Palazzolo to approve the minutes as written for December 15, 2014. On roll call; five ayes, no nays.

Mayor Policastro read the following communications:

From Police Chief Hines: December 2014 Monthly Report. Mr. Tinkham asked if we bought the new police vehicle. Chief Hines said it has been ordered but we will not get it for another 3-4 months but we did get the good price. Ms. Palazzolo said she noticed an arrest for drug paraphernalia which was categorized as general and then some specific to heroin and asked how they are categorized. Chief Hines said for instance if there is a syringe it would be paraphernalia but if the syringe was loaded with heroin in it then it would be categorized as both paraphernalia and heroin.

From Engineer Ertel: Memo Dated January 9, 2015 re: 2015 Street Rehabilitation Project. Mayor Policastro referred the matter to the Public Works and Service Committee. We always try to get this done in January. We get more bids and a lot more lower bids because the companies are hungry for the work early. If we wait too long like we did a couple of years ago we get very few bids. Fiscal Officer Borgerding said the Engineer's estimate should fall within what funds we should receive. Mayor Policastro said this year we have an agreement with Fairfax to finally get Belmont Avenue completed.

Ms. Schwartz moved, seconded by Ms. Palazzolo to nominate Mr. Marsland as Pro Tem of Council. Mr. Miller moved to nominate Mr. Wolter as Pro Tem of Council but did not get a second motion. On roll call; five ayes, no nays. Mr. Marsland was named Pro Tem of Council for 2015.

Mr. Tinkham moved, seconded by Ms. Schwartz to adopt the Annual Appropriation Ordinance. Fiscal Officer Borgerding said this is a reflection of the budget that Council adopted in July 2014. On roll call; five ayes, no nays. Ordinance No. O-1-15 was adopted.

Mr. Marsland moved, seconded by Mr. Miller to pay the bills as approved by the Mayor, Fiscal Officer and the Chairman of the Finance Committee. On roll call; five ayes, no nays.

The Mayor Policastro read the following miscellaneous announcements:

Ms. Palazzolo moved, seconded by Ms. Schwartz to appoint Mr. Miller as a Member of the Planning Commission. On roll call; five ayes, no nays.

Mayor Policastro referred to the Finance Committee the Salary Ordinance for Full-Time, Part-Time and Appointed Employees.
