ORDINANCE NO. 0-__13___-20

ORDINANCE LEVYING A \$5,00 MOTOR VEHICLE LICENSE TAX AS AUTHORIZED BY §4504.173 OF THE OHIO REVISED CODE AND ESTABLISHING NEW MARIEMONT CODE OF ORDINANCES NO. 110.12

WHEREAS, §4504 of the Ohio Revised Code authorizes the levying of certain taxes in addition to those taxes previously levied in accordance with §4504 by the State of Ohio; and

WHEREAS, §4504.173 of the Ohio Revised Code authorizes the legislative authority of a municipal corporation to levy an annual license tax upon the operation of motor vehicles on the public roads and highways in that municipal corporation for any authorized purpose; and

WHEREAS, the Finance Committee and the Village Solicitor have reviewed the Ohio Revised Code relative to these motor vehicle license taxes and finds that it would be in the best interest for the Village of Mariemont to implement same in accordance with §4504.173 of the Ohio Revised Code.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF MARIEMONT, STATE OF OHIO, TWO THIRDS OF THE MEMBERS DULY ELECTED THERETO CONCURRING:

SECTION I: There is hereby levied an annual license tax upon the operation of motor vehicles on the public roads or highways of the Village of Mariemont, Ohio, pursuant to §4504.173 of the Ohio Revised Code for the purposes of planning, constructing, improving, maintaining, and repairing public roads, highways, and streets, and to provide additional revenue for the purposes authorized by Section 4504.173(A)(2) of the Ohio Revised Code; and to supplement revenue already available for such purposes.

SECTION II: Such tax shall be at the rate of \$5.00 per motor vehicle per year, on each and every motor vehicle the district of registration of which, as defined in §4503.10 of the Ohio Revised Code, is in the Village of Mariemont, Ohio.

SECTION III: As used in this Ordinance, the term "motor vehicle" shall include all vehicles within the definition of motor vehicle in the Ohio Revised Code.

SECTION IV: The annual tax imposed by this ordinance shall apply to and be in effect for registrations beginning January 1, 2021, or at the earliest time legally authorized, and shall continue in effect and apply during each registration thereafter.

SECTION V: The annual tax imposed by this ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio, or to a Deputy Registrar, at the time of application for registration of a motor vehicle is made pursuant to the Ohio Revised Code.

SECTION VI: All revenues derived from the annual tax herein levied shall be used by the Village of Mariemont, Ohio for the purposes specified in this ordinance, or any other purpose authorized by state law.

SECTION VII: The Clerk of Council is directed to mail a certified copy of this Ordinance to the Bureau of Motor Vehicles, Tax Distribution Section in Columbus, Ohio upon passage.

SECTION VIII: That this ordinance shall go into effect at the earliest date allowed by law.
