ORDINANCE NO. O- 14 -20

**ORDINANCE LEVYING A SUPPLEMENTAL MOTOR VEHICLE LICENSE TAX AND ESTABLISHING
A NEW MARIEMONT CODE OF ORDINANCES NO. 110.13**

WHEREAS, the Finance Committee has authorized the levying of a motor vehicle license tax upon motor vehicles registered within the municipality as authorized by §4504.173 of the Ohio Revised Code; and

WHEREAS, §4504.172 of the Ohio Revised Code allows the municipality to pass supplemental legislation relative to the motor vehicle municipal license tax; and

WHEREAS, Council for the Village of Mariemont finds that it is appropriate to levy a supplemental municipal license tax as authorized by §4504.172 of the Ohio Revised Code.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF
MARIEMONT, STATE OF OHIO, TWO THIRDS OF THE MEMBERS DULY ELECTED
THERETO CONCURRING:**

SECTION I: There is hereby levied an annual supplemental license tax upon the operation of motor vehicles on the public roads or highways of the Village of Mariemont, Ohio, pursuant to §4504.172 of the Ohio Revised Code for the purposes of paying the costs and expenses of enforcing and administering the tax provided for in this section; to supplement revenue already available to the Village of Mariemont under §§4504.04, 4504.06, 4504.17, or 4507.171 of the Revised Code, and to provide additional revenue for the purposes set forth in those sections.

SECTION II: Such tax shall be at the rate of \$5.00 per motor vehicle per year, on each and every motor vehicle the district of registration of which, as defined in §4503.10 of the Ohio Revised Code, is in the Village of Mariemont, Ohio, and shall be in addition to the taxes at the rate specified in §§4503.04 and 4503.16 of the Revised Code as well as §110.12 of the Mariemont Code of Ordinances.

SECTION III: As used in this Ordinance, the term "motor vehicle" shall include all vehicles within the definition of motor vehicle in the Ohio Revised Code.

SECTION IV: The annual tax imposed by this ordinance shall apply to and be in effect for registrations beginning January 1, 2021, or at the earliest time legally authorized, and shall continue in effect and apply during each registration thereafter.

SECTION V: The annual tax imposed by this ordinance shall be paid to the Registrar of Motor Vehicles of the State of Ohio, or to a Deputy Registrar, at the time of application for registration of a motor vehicle is made pursuant to the Ohio Revised Code.

SECTION VI: All revenues derived from the annual tax herein levied shall be used by the Village of Mariemont, Ohio for the purposes specified in this ordinance, or any other purpose authorized by state law.

SECTION VII: The Clerk of Council is directed to mail a certified copy of this Ordinance to the Bureau of Motor Vehicles, Tax Distribution Section in Columbus, Ohio upon passage.

SECTION VIII: That this ordinance shall go into effect at the earliest date allowed by law.
