## Camping Rules & Regulations

1. You must be 21 years of age to secure a permit for use of the South 80 campsite.
2. The campsite must be reserved in advance through the Village Office.
3. Village Office will notify Mariemont Police & Fire of scheduled campouts.
4. A \$25 registration fee will be charged for each registration. The campsite can only be reserved for a maximum of three concurrent days / two nights. (Fee will be refunded within 30 days in the event campsite is closed due to high water level or if reservation is cancelled to accommodate Scouts.)
5. Priority for reservations will be given to the Mariemont Boy Scout and Girl Scout troops. The Boy and Girl Scouts will need to notify the Village Office of their intention to use the campsite at least 30 days before the anticipated campout dates.
6. Mariemont residents or employees may reserve the campsite 60 days before the start of the camping date. However, the Mariemont Boy and Girl Scouts will still have the ability to reserve the space and bump Mariemont residents or employees. If the site is not rented 15 days in advance before the start of the reservation period, then the site may be rented by non-Mariemont residents with priority given to Youth groups.
7. Permit holder must possess a valid photo ID and a signed copy of the camping permit while using the camping area.
8. Permit holder is responsible for all members of the party.
9. The Village of Mariemont shall not be responsible for damage to property or injury to persons which may arise or be incident to the exercise of the privileges granted by this permit. The permit holder will be responsible for taking all precautions for the health and safety of all participants.
10. Campers must sign waivers before use.
11. Camping limited to designated area only.
12. Maximum number of tents is ten 4-man tents (40 persons).
13. Only three cars may park in the provided parking area near the camping site. All other cars may park overnight in the swimming pool parking lot with an appropriate notice on the dashboard.
14. No bathroom facilities will be constructed or provided. Campers will be required to bring in their own portable toilets while using the campsite.
15. Alcohol is strictly prohibited at all times in all areas of the park.
16. No cutting of standing trees. Do not remove or disturb any vegetation.
17. Campers must follow fire pit rules as posted. Fire must be maintained within the fire pit area. A maximum of 5 logs are to be used at any time. Only natural wood is to be used – no woods with waterproofing or creosote.
18. Campers must remove all items when vacating premises and will be responsible for all damage.
19. Camping area will be closed during and after periods of heavy rain especially when the National Weather Service is predicting a rapid increase in the height of the Little Miami River or if they are predicting the river height at the Milford river gauge to exceed the ten foot level.

## Applicant's Acknowledgement of Rules and Waiver

I have read and understand the rules associated with camping in the South 80, and I agree that all members of my party will abide by them. I further agree to indemnify and save and hold harmless the Village of Mariemont from and for any and all liability, claims, suits, proceedings, demands, losses, damages, or expense of any name or nature, including administrative orders and proceedings, which applicant, or its invitees, sustains or incurs, including all claims regarding property loss, personal injury, or death, resulting in any way connected with Applicant's use of the South 80 property. Applicant assumes full risk of any loss, injury, or damages whatsoever occurring while applicant, or any of its employees, agents, or invitees, is utilizing the South 80 property owned by the Village of Mariemont. This acknowledgement is further a covenant not to sue the Village of Mariemont for any cause or matter referred to herein and Applicant agrees that the provisions contained herein are intended to be as broad and inclusive as permitted by the laws of the State of Ohio. This Agreement is freely and voluntarily signed with full knowledge of the consequences thereof.
