Example: Estimated Income of \$25,000.00:

Line 8 25,000. X 0.0125 = 312.50

Line 9b 25,000. X 0.01 = 250.00 (Not to exceed 1% of wages taxed)

Line 10 Line 8 minus Line 9c = 62.50 (Estimated tax for 20\_\_\_\_)

**If estimated tax due is OVER \$200.00, quarterly payments are required. Statements will be mailed at the end of each quarter. Full payment may be made at this time if preferred.**

**If payment is UNDER \$200.00, payment may be made now or at the time of 20\_\_\_\_\_ filing.**

**A payment plan can be arranged by calling the Tax Office for proper forms.**
